

# Privacy Policy

Cardio Renew is committed to protecting your privacy when you use our services ("Services"). In this policy we explain how and why we collect your information, what we do with it and what controls you have over our use of it.

From time to time, we add or change functions, features or products to our Web Sites or add or change Services. This, and our commitment to protecting the privacy of your personal information, may result in periodic changes to this Privacy Policy. As a result, please remember to refer back to this Privacy Policy regularly to review any amendments.

Your acceptance of these Privacy Statement terms

By using any of the sites within our web site network ("Web Sites") or our Services, you unconditionally agree to be bound by this Privacy Policy.

What data do we collect and how do we use it?

Cardio Renew may collect and process information about you in order to:

- identify you when you visit our Web Site or wish to have a Service provided;
- process orders submitted by you or Cardio Renew on your request;
- improve our Services and Web Sites; and
- send you information we think you may find useful, including information about new Cardio Renew products and services.

Log files/IP addresses

When you visit our Web Sites, we automatically log your IP address (the unique address which identifies your computer on the internet) which is automatically recognized by our web server. We use IP addresses to help us administer our Web Sites. We do not link IP addresses to personally identifiable information.

Non personal information

We may automatically collect non-personal information about you such as the type of internet browsers you use or the site from which you linked to our Web Sites. You cannot be identified from this information and it is only used to assist us in providing an effective service on our Web Sites.

Cookies

Cookies are pieces of information that a Web Site transfers to your hard drive to store and sometimes track information about you. Most web browsers automatically accept cookies, but if you prefer, you can change your browser to prevent that. However, you may not be able to take full advantage of a Web Site if you do so. Cookies are specific to the server that created them and cannot be accessed by other servers, which means they cannot be used to track your movements around the web. Although they do identify a user's computer, cookies do not personally identify customers or passwords. Credit card information is not stored in cookies.

We use cookies for the following reasons:

- To identify who you are;
- To estimate our audience size and patterns;

- To ensure that you are not asked to register twice; and
- To track preferences and to improve and update our Web Site.

With whom is the information shared?

No one. Cardio Renew will not share, sell, trade or rent your personal information to third parties. Cardio Renew may disclose aggregate statistics about our sales or our Web Site in order to describe our services to prospective partners, advertisers and other reputable third parties and for other lawful purposes, but these statistics will not include any personally identifying information. Cardio Renew may disclose personal information if required to do so by law or if it believes that such action is necessary to protect and defend the rights, property or personal safety of Cardio Renew and its Web Sites, visitors to the Web Sites and customers of our Services.

Information about products and services
